## Corporate Banking, Loan Syndication, and Cross-Border Lending

- In Myanmar, a consortium of Singapore-based banks (including Standard Chartered, ING, DBS, OCBC, and SMBC) on the first non-recourse, cross-border private sector loan financing. DFDL was recognized in the category "Innovation in Finance Law" (Asia-Pacific) by the Financial Times.
- In Bangladesh, DBS Bank on cross-border financing to a Bangladeshi borrower, including reviewing the facility agreement and assisting in the completion and satisfaction of the conditions precedent.
- In Vietnam, TEDIS, French-headquartered international pharmaceutical distribution group, in the structuring of its cross-border financing to TEDIS' subsidiaries, partners and distributors.
