Monthly Tax Returns

DFDL Mekong will assist you with calculation, preparation and lodgment of the monthly tax returns Tax and with tax authorities, including: prepare or review of prepayment of Profit Tax, Withholding Tax, Salary Tax and Fringe Benefit Tax, Value Added Tax and other monthly tax returns.

Annual Tax Return

Cambodian entities are required to submit an Annual Tax Return to the GDT within three months of the entities' year end, even if for a dormant entry.

Annual Patent Tax Renewal

Cambodian entities are obligated to renew their Patent Tax License every year before 31 March.

The Annual Declaration of Commercial Enterprise (ADCE)

Cambodian entities are required to lodge an Annual Declaration of Commercial Enterprise each year with the MOC, with deadline on 31 March.
